

Information public transportation

Information on the validity of the ski tickets / winter hiking tickets of the Arosa and Lenzerheide ski resort within the scope of the RhB (Chur – Arosa, 2nd class) and PostAuto (Chur – Lenzerheide – Tiefencastel)*





PUBLIC TRANSPORTATION INCLUDED

The ski tickets / winter hiking tickets / annual passes / season passes are valid for the return trip (2nd class) to the destinations Arosa and Lenzerheide in connection with their subsequent or prior use of the resort lifts for:

- Skiing (in winter sports equipment: ski clothing, ski boots, skis) including night skiing Lenzerheide
- Snowboarding (in winter sports equipment: snowboard clothing, snowboard boots, snowboard)
- Tobogganing (in winter sports equipment: winter wear, possibly sled) including night tobogganing Lenzerheide
- Winter hiking (in hiking equipment: winter clothing)
- Snowshoe hikes (in snowshoe equipment: winter clothing, snowshoes)
- Paragliding (with paragliding backpack)

Usually the inclusion is recognisable by the imprint on the card or is listed in the booking confirmation. This listing is exhaustive.

PUBLIC TRANSPORTATION NOT INCLUDED

For all other journeys, the ski tickets / winter hiking tickets / annual passes / season passes of the ski resort are not valid at RhB and PostAuto.

Examples:

- Cross country skiing, ice skating
- Shopping, visits, excursions, trip to the restaurant
- Work, school
- EarlyBird
- Winter-/snow shoe hiking/tobogganing in Chur
- Arrival at and departure to the holiday region without valid ski ticket/winter hiking ticket
- Season passes of the snow sports instructors / employees ski lift companies
 - Can not be used for work, but only for the pursuit of winter sports in leisure time when wearing leisure clothing.

Second home owners, ski-locker users and groups

With a annual / season pass or as a group, the Arosa and Lenzerheide ski lift companies can provide a confirmation which entitles them to use the above-mentioned public transport routes free of charge for the arrival or departure without winter sports equipment. The season pass does not have to be on hand.

Arrival and departure

The offer entitles the guest to use of the public transport routes for the arrival as defined above (maximum 1 day before the validity of the ski ticket/winter hiking ticket) as well as for departure (maximum 1 day after the validity of the ski ticket/winter hiking ticket, skiing equipment included).

Refund of wrongly paid public transport tickets

If a passenger has wrongly purchased a separate public transport ticket (Chur-Arosa, 2nd class or Chur-Lenzerheide-Tiefencastel), the amount will be refunded at the cash desks of the ski lift companies after examination. The refundable route must be purchased separately. The ticket must be given to the cash desk.
